**REVIEW OF EFFICIENCIES AND INCREASED ACCOUNTABILITY OF THE OAKBROOK TERRACE PARK DISTRICT TO PREPARE THE REPORT FOR THE COUNTY BOARD OF DUPAGE COUNTY**

Superintendent Jevaney presented a draft version of the Decennial Committee on Government Efficiency report in Director Elsey's absence. This draft included specific examples related to the operations of the Oakbrook Terrace Park District. The Committee reviewed the draft and discussed the included efficiencies of the Oakbrook Terrace Park District as outlined in the report.

While reviewing the draft, Commissioner Joy and Commissioner Rispens both noted that there are opportunities for growth concerning volunteers. It was suggested, for example, that volunteers could complete simple maintenance tasks or trash pick-up in the parks as a form of community service. Superintendent Jevaney noted that the suggestion will be included as one of our recommendations for increased accountability and efficiency in the final report for DuPage County.


