#### **ORDINANCE NO. 2013 –725**

# ORDINANCE PROVIDING FOR THE BUDGET AND APPROPRIATIONS OF THE OAKBROOK TERRACE COMMUNITY PARK DISTRICT, DUPAGE COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2013 AND ENDING APRIL 30, 2014

**WHEREAS**, the Board of Commissioners of the Oakbrook Terrace Community Park District, DuPage County, Illinois, cause to be prepared in tentative form a Budget and the Secretary of this Board has made the same conveniently available for public inspection for at least thirty (30) days prior to final action thereon; and

**WHEREAS**, a public hearing was held as to such Budget on the 25<sup>th</sup> day of July, 2013 and Notice of said hearing was given at least thirty (30) days prior thereto as required by law, and the Board having met all other applicable legal requirements.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of the Oakbrook Terrace Community Park District, DuPage County, Illinois, as follows:

**Section 1**: That the fiscal year of this Park District is hereby fixed to begin on May 1, 2013 and end on April 30, 2014.

Section 2: That the following Budget containing an estimate of the revenues available and expenditures and the appropriations contained therein be and the same is hereby adopted as the Budget and Appropriations for this park district for this fiscal year; and the following sums of money, or as much thereof as may be authorized by law, is hereby appropriated to defray the necessary expenses and liabilities of the Oakbrook Terrace Community Park District, for its fiscal year beginning May 1, 2013 and ending April 30, 2014 for the respective objects and purposes, as hereinafter set forth namely:

<u>Section 3</u>: That all unexpended balances of any item or items of any general appropriation in this Ordinance be expended in making up any insufficiency in any other item or items in the same general appropriation and for the same general purpose of any like appropriation made by this Ordinance.

**Section 4**: That the invalidity of any item or Section of this Ordinance shall not affect the validity of the whole or any other part hereof.

<u>Section 5</u>: That this Ordinance shall be in full force and effect from and after passage, approval and publication as provided by law.
