

On Friday, March 13, the Oakbrook Terrace Park District announced that in order to prevent the further spread of the COVID-19 virus, we are suspending all programs and activities, as well as closing all facilities until further notice.

We expect to re-open for all facilities, programs, classes and events on Monday, May 4 during regular business hours. The Park District will continue to work closely with local city, school, and health department authorities to monitor the coronavirus pandemic and will re-evaluate the situation and inform the community of any new updates. If this date needs to change due to a change in CDC guidelines or at the order of state officials, we will keep you informed.

Please notify the Park District if you have come in contact with a person who is showing signs of COVID-19 symptoms.

We recognize the seriousness of the spread of the coronavirus disease (COVID-19) in our community. Help prevent the spread of respiratory diseases by consistently following the Center for Disease Control's preventative actions:

- Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer with at least 60% alcohol.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.

Why did you close Park District facilities?

In light of the increased spread of COVID-19 and the importance of social distancing, the Park District decided it was socially responsible to cancel all programs and activities and close all facilities. Will you be cleaning the facilities during the closure?

Yes, deep cleaning of all facilities will be done before re-opening.

Will I be billed for my membership/program while the Park District is closed?

Any automatic billing will not take place until the Park District is fully operational. This includes billing for Fitness Center memberships.

What are my current registration options?

In-person registration operations are suspended throughout the length of the closure. [Online registration](#) remains available 24/7.

Are the parks open?

Per Illinois Executive Order 2020-10, all Park District playgrounds are closed to public use until further notice. However, individuals may still leave their residences to engage in outdoor activity such as walking, hiking, running or biking and may go to public parks and open outdoor recreation areas if they comply with the Social Distancing Requirements defined in the order.

To comply with social distancing best practices, we encourage you to use your best judgment when going to the parks, and you do so at your own risk. To help prevent the spread of respiratory viruses, we encourage you to wash your hands and your child's hands before and after being in any public area and maintain proper social distancing of six feet or more.
